



Calhoun County Schools Non-Resident Student Enrollment Application 2023-2024

Eligibility

Calhoun County Schools is offering limited non-resident student enrollment opportunities for the 2023-2024 academic year. Schools that are available to receive non-resident student applications are as follows:

- **Ohatchee Elementary School**
- **Pleasant Valley Elementary School**
- **Wellborn Elementary School**
- **Alexandria Middle School**
- **White Plains Middle School**

All applications for non-resident enrollment will be reviewed by a Calhoun County Schools district administrator. Only applicants that are in "good standing," i.e., academically, behaviorally, regular in attendance, and supported by parental cooperation, will be considered. **If accepted, the parent(s)/guardian(s) of the student will be expected to submit the established tuition fee of \$1,500.00 per student within 7 business days. If fees are not paid within this timeframe the enrolment will be made available to students on the waiting list.**

In addition to this application, parent(s)/guardian(s) will be asked to provide the following documentation:

- Proof of legal guardianship
- Residency verification
- A copy of educational records for the current school year. Educational records must include a copy of the current report card, transcript, discipline, and attendance records. Educational records for up to three years may be requested.

No application will be considered complete until all educational records from the student's current and/or previous school(s) have been received.
